Dear Mr.Bodmar,

Thank for your letter to the World Health Organization (WHO) requesting information on our materials published on the topic sexual education. In this regard, I am happy to provide you the references below. There are numerous publications on this topic, but here I have selected for you the ones that are more relevant to your questions.

## 1. "Which document should be considered the one that determines the World Health Organization's current standards and guidelines on sexuality education?"

I am referring you to our most recent document, an international technical guidance on sexuality education published by UNESCO in collaboration with WHO: *International technical guidance on sexuality education, An evidence-informed approach.* Available at <a href="https://www.who.int/reproductivehealth/publications/technical-guidance-sexuality-education/en/">https://www.who.int/reproductivehealth/publications/technical-guidance-sexuality-education/en/</a>. This document provides a review of the current evidence and best practices from various regions and reaffirms that sexuality education has positive effects on young people with regard to their sexual and reproductive health.

This document is more recent than publication *Standard in Sexual Education* <a href="https://www.bzga-whocc.de/en/publications/standards-in-sexuality-education/">https://www.bzga-whocc.de/en/publications/standards-in-sexuality-education/</a> published by the Federal Centre for Health Education (BZgA), which is a WHO Collaborating Center (WHO CC) for Sexual and Reproductive Health since 2003. Both documents are technically aligned.

In addition, I am enclosing several policy briefs on sexuality education which outlines the latest position on sexual education. Policy Brief 2 is very useful for giving examples of sexuality education impact on health of adolescents and provide strong evidence from countries such as Estonia, Finland, Germany. Policy Brief 3 cover the process of introducing sexual education programs. We want to emphasize that
