TIRANA – A seminar on the protection of human rights and ombudsman's role organized by the Polish Ambassador to Tirana, Marek Jeziorski in cooperation with Albania's Ombudsman's Office highlighted on Monday the importance of the people's advocate for the protection of human rights in general but underscored how important it is to reach out to individuals, ordinary people in a country.


Igli Totozani, Albania's Ombudsman, expressed his pleasure about the support that Speaker Ilir Meta had given to his institution.
